

TERMS AND CONDITIONS

Organiser & Qualifications

1. The Eonsave **“MyDebit Je dengan kad ATM anda dan MENANG!”** **["Contest"]** is jointly organised by Eonsave Cash & Carry Sdn Bhd (Company Number:199601018639(390990-T)) and Payments Network Malaysia Sdn Bhd (Company Number: 200801035403(836743-D)) (PayNet) **[collectively referred as “The Organiser”]**.
2. The Contest is open to all permanent residents in Malaysia or Malaysian citizens who are 18 years and above and have a valid identification document during the Contest Period and a MyDebit Automated Teller Machine **["ATM"]** cardholder issued by the financial institution in Malaysia is eligible to participate to the Contest **["Participant"]**.
3. The Participant must also have a valid account with any of the financial institution in Malaysia and the account must be in a good financial standing and not dormant during the Contest Period until the completion of the redemption of prizes.
4. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organiser [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or
 - Representatives, employees and/or the advertising agencies or promotional agencies of the Organiser [including its associated and related companies], and their immediate family members [children, parents, siblings, spouses].

5. Each entry must be attached with clearly printed transaction slip/bank slip printed from terminal to be accepted as a valid entry [**"Proof of Purchase"**].
6. Participant who is selected as winner is required to submit their Proof of Purchase before the redemption/fulfillment of the prizes can be completed. Failure to do so would result in the cancellation of the prizes won by the Participant.

(Note: each accumulated value of RM80 = 1 serial number, RM160 = 2 serial number, RM240 = 3 serial number and so forth) (Note: Serial number is for the Organiser's reference/view and will not be disclosed to the Participant).

- **How to Participate (2): via Whoop app (downloadable via Play Store for Android/App Store for iOS)**

- i. Sign up for Whoop! App (registration for the first time only);
- ii. Click on the Econsave "**MyDebit Je dengan kad ATM anda dan MENANG!**" banner;
- iii. Take a photo of the Proof of Purchase and keep the Proof of Purchase;
- iv. Correctly answer the Contest questions and complete the required information;
- v. Participant will receive an immediate acknowledgement upon submission;
- vi. By submitting entries via Whoop! app, the Participant is deemed to have read and agreed to the Privacy Notice set forth in the Terms and Conditions herein;
- vii. Note: Every valid purchase worth RM80 and above (in a single transaction slip) will be given **ONE (1)** random serial number. (Note: each accumulated value of RM80 = 1 serial number, RM160 = 2 serial number, RM240 = 3 serial number and so forth) (Note: Serial number is for Organiser's reference/view and will not be disclosed to the Participant).

2. Participant may send more than ONE (1) entry.
3. Each Proof of Purchase can only be used once. The Participant's entry will be disqualified if the same Proof of Purchase is used for more than ONE (1) time.

Winners' selection
