

## TERMS AND CONDITIONS

### EXTENSION MEGA COMBO 2024

#### 1. PROMOTION EXTENSION PERIOD

- a) Mega Combo 2024 promotion extension (“Promotion Extension”) will start from **1 August 2024** and ends on **30 September 2024**, both dates inclusive (“**Promotion Extension Period**”).
- b) Bank Pertanian Malaysia Berhad (“**Agrobank**”) Company No. 200801010522 (811810-U), reserves the right to change the duration and/or the commencement and/or expiry dates of the Promotion Period by giving twenty one (21) calendar days’ prior notice.

#### 2. TERMS AND CONDITIONS

- a) The following sets out the Terms and Conditions applicable to the Promotion (“**T&Cs**”).

#### 3. ELIGIBILITY

- a) The Promotion is open to **all new and existing individual Customers** of Agrobank (“**Customers**”) who possess the following criteria:-
  - i. Malaysian citizen, or permanent resident, or non-Malaysian citizen who resides in Malaysia and possess the valid visa to stay in Malaysia not less than twelve (12) months in Malaysia;
  - ii. Possess valid identification document; and
  - iii. Eighteen (18) years old and above.
- b) The Customers are required to open new Fixed Return Islamic Account-*i* (**FRIA-*i***) or Fixed Return Islamic Account-*i* 45Plus (“**FRIA-*i* 45Plus**”) together with AgroPrimaS account (**AgroPrimaS**) (collectively referred to as “**Products Accounts**”) for this Promotion.
- c) The Agrobank’s staffs are ineligible to enjoy the profit rate under this Promotion (“**Promotional Profit Rate**”). However, family members and relatives of the Bank’s staffs are eligible to enjoy the Promotional Profit Rate.
- d) The eligibility criteria for this promotion are subject to the terms and conditions set for each Product Account.

#### 4. PROMOTION MECHANISM

- a) The deposit placement into the Product Account must be debited from the Customer’s savings account with Agrobank.
- b) The deposit ratio placement for this Promotion is 70:30 for FRIA-*i* Account or FRIA-*i* 45Plus Account and AgroPrimaS account.
- c) Customers who meet the eligibility criteria of this Promotion are eligible to enjoy the promotional rate listed in the table below for a period of **twelve (12) months**.

- d) The minimum deposit placement amount into the Products' Accounts is RM10,000\*. New fund is highly encouraged for this Promotion.  
*(Note: "New fund" is defined as cash, interbank transfer (which includes Interbank GIRO (IBG), instant transfer and DuitNow), new funds received via telegraphic transfer from other banks, local cheque or banker's cheque issued by other banks)*
- e) The Promotional Profit Rate stated in the table above is applicable for **one (1) cycle only i.e., twelve (12) months** from the date of the deposit placement. Upon maturity, the principal amount shall be automatically renewed at the prevailing board rates for the same tenure.
- f) The Promotional Profit Rate paid will be credited into the Customer's saving account with Agrobank upon account maturity.
- g) Partial upliftment from the Products' Accounts before maturity period is not allowable.
- h) No Promotional Profit Rate will be paid for any pre-mature upliftment from any of the Products' Accounts.
- i) Any Customer who fails to meet the deposit ratio placement requirement under this Promotion will not be eligible for the Promotional Profit Rate.
